(ii) The words PH-I, PH-II and PH-III shown in the vacancy position represents Visually Impaired, Hearing Impaired and Orthopedically Impaired respectively.

(iii) Candidate selected against vacancies earmarked for physically handicapped & Ex-Serviceman will be adjusted against the relevant categories i.e. OC SC, ST and OBC as the case may be depending upon the category to which the selected candidate belongs to.

(2) The para 4 B (i) of notification no. R&E/2-9/DR/2015-16 dated 12.03.2016, is deleted and is replaced by :-

**4 Eligibility Conditions**

**b. Age Limit-** 18 to 27 years for unreserved (UR) applicants.

(i) Permissible relaxation of upper age limit as per Govt. of India orders are as indicated below:

<b>Category .</b>	<b>Age relaxation permissible beyond the Upper age limit</b>
Scheduled Castes/ Scheduled Tribes (SCs/STs)	5 years
Other Backward Classes (OBC)	3 years
Physically Handicapped(PH)	10 years
PH+SC/ST	15 years
PH+OBC	13 years
Ex-servicemen	3 years after deduction of service rendered in military from the actual age as on the closing date for registration of application.
Ex-Servicemen+SC/ST	8 years(3 years +5 years) after deduction of the military service rendered from the actual age as on the closing date.
Ex-Servicemen+OBC	6 years (3+3 years) after deduction of the military service rendered from the actual age as on the closing date.
Government servants (who have rendered not less than 3 years' regular continuous service as on closing date for registration of application)	Upto 40 years of age 45 years for SC/ST and 43 years for OBC.

The age relaxation for reserved category applicants (SCs/STs/OBCs) is admissible only in the case of vacancies reserved for such categories. The reserved category applications, who apply against posts meant for UR category, are not entitled to get age relaxation.

Any person who claims to belong to a Scheduled Caste or a Scheduled Tribe or Other Backward Class should be in possession of the relevant community certificate as on closing date of registration and have to produce a certificate to the appointing authority, issued by competent authority in prescribed Performa, at the time of selection in support of his/her claims. Format for SC/ST/OBC/PH is enclosed for ready reference. The claim/concession will be entertained as per departmental rules/guidelines on the subject.

- (3) Para 4 b (iii) is inserted below para 4 b (ii) of notification no. R&E/2-9/ DR/2015-16 dated 12.03.2016 as:-

“The candidates are themselves responsible for ensuring that they fall within the prescribed age limit and also fulfil other eligibility criteria. If any stage it is found that they do not fulfil the age criteria or any other eligibility criteria, their candidature will be cancelled.”

- (4) Para 2 E is inserted below para 2 D of notification no. R&E/2-9/ DR/2015-16 dated 12.03.2016 as:-
